Any work performed within the right-of-way of a Borough road, requires submission of three (3) copies of this form along with three (3) copies of a sketch showing location and details of proposed work.

Any work performed on a Borough road over, under, or within, the limits of a limited access state highway, requires a state permit. The prescribed permit fee shall accompany the application and sketch. Schedules of fees are furnished on request.

THE FEE SHALL BE PAID BY CHECKS OR MONEY ORDERS, AND SHALL BE MADE PAYABLE TO THE CORNWALL BOROUGH.

Schedule of Fees

The following fees are established and collected to cover the Borough's costs for inspection of construction work performed by others. These fees are in addition to the Issuing Fee of \$25.00 which covers the cost of Administration and Overhead. These fees do not include engineering review costs of subdivision or land development plans, grading plans, stormwater management plans or calculations, conservation plans, or any other special designs required by the Borough as a condition of issuance of the Road Occupancy Permit. Engineering fees will be billed to the applicant as an additional charge at the prevailing rates of the Borough Engineer.

SCHEDULE A

This schedule is intended for very small projects, such as a utility lateral connections or road crossings for which the area of pavement to be cut is generally less than 100 s.f. and the duration of work is generally only a portion of one day. For larger projects, see Schedule B.

SCHEDULE B

For larger projects, such as long extensions of new utility lines which require more than 100 s.f. of road cut or which will have a duration of many days, the fee shall be established by the Borough based upon an hourly estimate of the amount of engineering reviews and inspection time multiplied by the prevailing Borough Engineer rates. In the case that the amount of time required by the Borough for reviews and inspections exceed the initial fee charged by the Borough, the Applicant shall be responsible to pay the increased costs. If an applicant disputes the estimate prepared under Schedule B, then the unit costs established in Schedule A will apply.
